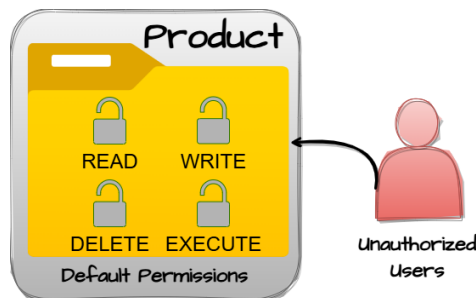

Potential Mitigations

Phase(s)	Mitigation
Architecture and Design; Operation	The architecture needs to access and modification attributes for files to only those users who actually require those actions.
Architecture and Design	<p>Strategy: Separation of Privilege</p> <p>Compartmentalize the system to have "safe" areas where trust boundaries can be unambiguously drawn. Do not allow sensitive data to go outside of the trust boundary and always be careful when interfacing with a compartment outside of the safe area.</p> <p>Ensure that appropriate compartmentalization is built into the system design, and the compartmentalization allows for and reinforces privilege separation functionality. Architects and designers should rely on the principle of least privilege to decide the appropriate time to use privileges and the time to drop privileges.</p>

Vulnerability Mapping Notes

Usage	ALLOWED (this CWE ID may be used to map to real-world vulnerabilities)
Reason	Acceptable-Use
Rationale	This CWE entry is at the Base level of abstraction, which is a preferred level of abstraction for mapping to the root causes of vulnerabilities.
Comments	Carefully read both the name and description to ensure that this mapping is an appropriate fit. Do not try to 'force' a mapping to a lower-level Base/Variant simply to comply with this preferred level of abstraction.

Notes

Maintenance

As of CWE 4.19, this entry is being considered for deprecation or significant revision. Its name and description are inconsistent. The name is more general, and the description is more specific. The description emphasizes the installation phase only; mentions only files; and emphasizes modification of those files. The name applies to any type of resource, does not mention the specific permissions, and could be relevant to any SDLC phase.
